

### Immediate college enrollment following high school graduation, by percentile of district poverty and FAFSA completion status.






Percentage of fall 2009 ninth-graders who did not complete the Free Application for Federal Student Aid (FAFSA), by socioeconomic status: 2013

#### **Average FAFSA Completion Rate by Percentile of District Poverty**






Percentage of fall 2009 ninth-graders without a completed Free Application for Federal Student Aid (FAFSA), by reasons for not completing a FAFSA: 2013



#### FINDINGS FROM OTHER SOURCES

#### Education Northwest: The literature tells us that students and families...

- think they do not have financial need
- 2. lack awareness and information about financial aid
- 3. are deterred by the cost of college and the thought of taking on debt
- 4. are put off by the complexity of the FAFSA form and process
- face similar barriers to FAFSA renewal

#### **Big Myths:**

- "FAFSA is a waste of time because college is too expensive."
- "My parents make too much money to qualify for aid."
- "Applying is unsafe, and as an undocumented student, I won't get any money anyway."
- "FAFSA will force me to take out loans, and I don't want to take out any loans."



#### FINDINGS FROM OTHER SOURCES


#### EAB:

- "Students, particularly first-generation and low-income students, don't understand how financial aid could work for them. They often think they won't qualify for aid and therefore don't file. When they do file the FAFSA, it's a challenging experience because they are often doing it on their own or with limited help."
- "...almost 30% of the low-income students who did not plan to file a FAFSA said they did not think they would qualify for financial aid. And 10% of these students said either they did not have help or had trouble getting the required documentation."

<u>Davidson (2013)</u>: "Across five national surveys, the top two answers were that students or parents did not have financial need or did not think they would qualify. However, a third of students who indicated they did not need aid were actually eligible, which reveals common misperceptions about who is eligible and how students qualify for aid."

#### PELL ON THE TABLE: IMPLICATIONS FOR ALASKA

- Alaska's class of 2022 left ~\$7 million in Pell Grants on the table
- 31% of Alaska's FAFSA applicants were Pell Grant eligible (national average was 47%)
- The average Pell Grant award for Alaska high school graduates was \$4,243
- 65% of high school graduates did not complete the FAFSA





#### **Year-Over-Year % Change in FAFSA Completions**






#### TWO METRICS WILL APPEAR AGAIN AND AGAIN TODAY





#### Estimated % of U.S. Seniors Completing a FAFSA, Through June 30, 2023





#### Estimated % of U.S. HS Seniors Completing FAFSA, Classes of 2017-2023, by ~June 30
















On average, **Western states** are below average by % of seniors completing, but many Western states saw aboveaverage yearover-year changes in FAFSAs for the class of 2023.



Year-Over-Year % Change in FAFSA Completions, by U.S. Census Region, 2023-24 Cycle, Through June 30, 2023




For the high school class of 2023, Western states saw the largest year-over-year gains by U.S. Census region.





Despite those year-over-year (relative) gains, it's clear that Western states have a lot of room to grow in terms of absolute FAFSA completion performance.





Equity Indicator 5a(i): Estimated bachelor's degree attainment by age 24 for dependent family members by family income quartile: 1970 to 2020










A strategic, data-driven campaign to encourage as many students as possible to submit the FAFSA, with a special emphasis on submitting the FAFSA in time to remain eligible for the TN Promise scholarship.

### North Greene High School FAFSA Update

FAFSA Deadline Change: Due to the evolving nature of the COVID-19 pandemic and recent weather events, the Tennessee Promise Scholarship FAFSA deadline has been extended to March 1, 2022.

71.90% of Tennessee Promise applicants have <u>completed</u> a FAFSA.

74% of applicants have <u>submitted</u> a FAFSA. The statewide FAFSA completion rate is currently 53.8%.

The data above reflects FAFSAs filed on or before January 23, 2022. Completed FAFSAs are those where all of the information on the FAFSA is complete and an EFC has been created. A FAFSA that is submitted but not complete may be missing information or signatures. Students will need to complete the FAFSA in order to receive state or federal financial aid.

Make sure that your school is participating in the TN FAFSA Challenge. Schools that increase the FAFSA completion rate of TN Promise applicants by 5 percentage points over last year will be recognized as FAFSA Champions. Additionally, we plan to recognize high schools with the highest year over year increase and the highest completion rate. To learn more, visit the TN FAFSA Challenge webpage.





# Collaboration: TN FAFSA Challenge

Initiative began in 2021

There are two ways a high school can earn FAFSA Champion status:

- (1) Increase their Tennessee Promise applicant FAFSA completion rate by 5 percentage points or more compared to the previous academic year as of the Tennessee Promise FAFSA deadline
- (2) Have 95% or more of their Tennessee Promise applicants complete the FAFSA as of the Tennessee Promise FAFSA deadline
- Categories for Highest Completion and Most Improved
- Banners, Media, Acknowledgement





# Outcomes: TN FAFSA Challenge

75 high schools designated FAFSA Champions

### New criteria for 2022 – 2023

- (1) Increase their Tennessee Promise applicant FAFSA completion rate by 5 percentage points
- (2) Have **90%** or more of their Tennessee Promise applicants complete the FAFSA as of the Tennessee Promise FAFSA deadline
- Categories for Highest Completion and Most Improved
- Banners, Media, Acknowledgement







## **ISAC: RECOGNITION OF EXCELLENCE AWARDS**

Recognition of efforts from high schools that focus on supporting their students and families through

the financial aid process

- Recognition is awarded based on the school's financial aid application completion rates
- Completion rates are calculated based on the high school's class roster that were provided in one of two ways:
  - ISBE-provided data (public high schools)
  - Class roster upload (Private schools)




# DUAL ENROLLMENT IS A RAPIDLY GROWING GLIDE PATH TO POSTSECONDARY EDUCATION

The number of dual-enrollment students at community colleges has nearly doubled in a decade.

More than a million dual-enrollment students were enrolled at community colleges in the fall of 2021, an increase of about 510,000 students from a decade earlier.

Number of dual-enrollment students at community colleges






## High-school students have made up an increasingly large share of communitycollege enrollment in recent years.

The share of high-school students who were enrolled in community college was up 11 percentage points in the fall of 2021 from a decade earlier.





## High School Students as a Percent of Fall 2021 Community College Enrollment





#### Illinois Pace Postsecondary and Career Expectations

Each student should have an individualized learning plan to help make decisions about career and post-secondary (PS) education or training, to plan a course of study, and to make financial aid assessments with family members.



#### By the end of 8th grade

#### A student should be supported to:

- complete a career cluster survey
- attend a career exploration day
- complete a unit on education planning
- be exposed to a financial literacy unit in a course or workshop

#### A student should know:

- the concept of career clusters of interest
- relationship between community service/extracurricular activities and postsecondary (PS)/career goals



#### By the end of 9th grade

#### A student should be supported to:

- o revisit career cluster interest survey and take a career interest survey
- complete an orientation to career clusters
- attend a PS options workshop
- meet with a counselor to discuss coursework and PS/career plans using the ISBE College and Career Readiness Indicators
- begin determining eligibility for advanced placement (AP) courses
- outline a plan for community service and extracurricular activities related to PS plans
- complete a financial aid assessment with a family member

#### A student should know:

- one or two career clusters for further exploration and development
- the relationship between HS cousework, attendance, and grades to PS plans
- and extracurricular activities to PS and career plans
- options

#### By the end of 10th grade

#### visit at least one workplace aligned with career interests

o complete an orientation course to a particular career cluster or cluster grouping

A student should be supported to:

- select a career pathway (CP) within a career cluster of interest
- begin determining eligibility for AP courses
- identify 2-3 adults to support the student through the PS and career selection process
- review coursework, and PS/career plans in relation to the ISBE College and Career Readiness Indicators (every year)
- attend a PS affordability workshop with a family member

#### A student should know:

- educational requirements, cost. expected entry level, and midpoint salary for occupations in selected
- different types of PS credentials and institutions
- general timing of PS entrance exams and applications
- benefit of early college credit opportunities to PS access and completion

#### By the end of 11th grade

#### A student should be supported to: o revisit the career survey

- participate in a mock job interview
- create a resume and personal
- statement
- identify an internship opportunity related to the CP
- determine readiness for college-level coursework in math/ELA and enrollment in either "catch up" or "speed up" course
- complete or enroll in at least one early college credit opportunity
- attend a college fair
- visit at least 3 PS institutions
- take at least one college entrance

#### A student should know:

- application deadlines, test timing. cost, and preparation for industry-based certification for CP
- o career attributes related to career interests
- entrance requirements, including application deadlines, for expected PS programs of study
- 3-5 match schools, one safety, one reach school for PS program of study
- negative impact of remediation on PS goals
- financial aid deadlines for chosen PS options

#### By the end of 12th grade

#### By 12/31 of 12th grade a student should have:

- completed 3 or more admissions applications to PS institutions
- met with a school counselor to ensure all steps in the PS admissions process are completed on time
- attended a FAFSA completion workshop
- completed the FAFSA

#### By the end of 12th grade a student should be supported to:

- address any remedial needs in math/FLA
- o obtain an internship opportunity related to the CP
- if applicable, receive industry-based certification(s) related to the CP
- o complete one or more team-based challenges or projects related to the CP
- attend a financial aid award letter workshop

#### A student should know:

- how CP courses and experiences articulate to degree programs at PS options
- estimated cost of each PS option
- affordability of PS options in relation to expected entry-level career salary and anticipated debt
- terms and conditions of any scholarship or loan

- importance of community service
- general cost ranges of various PS













The CCR course may be taught in one of the following sequences:

- Senior year only
- Junior year only
- 1 semester in the junior year with the remaining semester taught in the senior year
- 1 semester in either freshman or sophomore year with the remaining semester taught in junior or senior year

## **UNIT 4: APPLY FOR FINANCIAL AID**

## **Competencies and Suggested Objectives**

## 1. Complete applications for financial aid.

- 1. Develop an understanding of what the Free Application for Federal Student Aid (FAFSA) is, how it is used, and why it is important.
- 2.Create a Federal Student Financial Aid username and password (FSA ID) to be used for all studentaid.gov applications such as FAFSA and federal student loans.
- 3. Determine eligibility for Mississippi's grant programs based on information obtained from the ISP.
- 4. Research and apply for available private scholarships (national, regional, and/or local).
- 5. Research and complete the scholarship application for each chosen college/university.
- 6.(Seniors Only) Complete the FASFSA at <u>studentaid.gov</u> between October 1 and March 31 or complete a mock FAFSA via the Federal Student Aid FAFSA Demo site.
- 7.(Juniors Only) Complete a mock FAFSA via the Federal Student Aid FAFSA Demo site.
- 8.(Seniors Only) Complete the Mississippi Aid Application (MAAPP) at <u>msfinancialaid.org</u> between October 1 and March 31.



## **INITIAL CCR COURSE TASK FORCE**

- 34 members
- Lead by the MS Department of Edu Director of P20 Partnerships
- Composition:
  - 14 members representing high schools (teachers, counselors academic & CTE, admin, district, pilot sites)
  - 10 members representing state agencies (State Treasurer's office, colleges governing board, MS Office of Student Financial Aid)
  - 5 members representing colleges (admissions, financial aid)
  - 4 members representing subject matter expertise/community (Mississippi Economics Council, Get2College, Secretary of Treasury)



## APPROACHING COLLEGE & CAREER STATE-WIDE COLLEGE & CAREER

- 2015: MS Department of Education began research/work around updated diploma options and graduation requirements
- 2017: Creation of the CCR Curriculum Task Force by MS Department of Education (MDE); determined cohort (class of 2022) to earn new diploma options entered high school
- 2018: Developed an outline of CCR curriculum after reviewing the 4 MDE seminar courses utilized by the students enrolled in early college programs; year 1 of pilot school districts
- 2019: Year 2 of pilot school districts; reviewed/implemented suggested revisions of curriculum outline from year1 pilots; developed a full course curriculum of 8 units
- 2020: Creation and final version of CCR curriculum, approved by the State Board of Education
- 2022: Graduation requirement for all students moving forward
- 2023: Curriculum reviewed, updated, and approved by the State Board of Education for next 3years (23-26)









## There has been considerable attention on "Universal FAFSA" policies

## **NCAN Recommends that States:**

- •Require FAFSA completion for high school graduation through legislative or other policy vehicles.
- •Include a robust opt-out system for students who are unable to access parental financial information, have undocumented parents, or whose parents allow them to abstain.
- •Provide (at minimum) one full FAFSA cycle from the bill passing, or the item being administratively added to a list of requirements before the actual requirement takes effect.
- •Make the change administratively, if high school graduation requirements do not live in statute.
- •If not already in place, build and provide robust training and support through school counselors and/or college access advisers to ensure students are helped through the process.
- •Provide regular data-sharing on completion to high schools and community-based organizations to allow for better-targeted FAFSA completion efforts.
